NOTE FACTS OF ARREST NOT INCLUDED ABOVE. On April 7, 2015 Lt. Randy Powell was conducting an investigation in reference to a male subject sitting inside his vehicle with loud music coming from the vehicle. On my investigation a male subject identified as Jelani Barr, came to the scene while the investigation was in progress. Mr. Barr began to use insulting degrading language toward myself and members of the Greenwood Police Dept. while properly performing his official duties. Mr. Barr stated continued stated that members of the police department are not trained and harassing our black men. Mr. Barr clearly violated the safety zone in which the investigation was being conducted at that time. The investigation could not be performed properly due to the interference of Mr. Barr. On 3/24/2015 while Sgt. Michael Hoskins and I was investigating an accident at MLK and HWY 82. Mr. Barr interfered with the investigation and he entered the safety zone by stating "Look they have no training, they are not properly trained". Again Sgt. Hoskins and I could not properly conduct official police duties. And Mr. Barr was asked to leave the investigative scene, because he was interfering with the duties of police officers. This is insulting language toward members of the police dept. According to City Ordinance Subsection 13-10 - Cursing, etc., of officers of city. It shall be unlawful for any person to curse, insult, deride, ridicule or use abusive language towards a member of the police department of the city, or a member of the auxiliary police force of the city, or a member of the fire department of the city, while said member of the police department, or member of the auxiliary police force, or member of the fire department is properly performing his official duties.




On April 8, 2015 Lt. Powell advised headquarters that he needed more units at the scene where he was conducting his investigation at Triple Stop Store on Bowie Lane and Carrolton Ave. Upon arriving on the scene I Sgt. Hoskins observed that Lt. Powell had a male subject that was standing outside the vehicle and was being placed under arrest. As Lt Powell continues his investigation a black male (Jelani Barr) walked into the safe area of the investigation with a cell phone that was recording the investigation. Mr. Barr began to state this is an example of another black man being harassed by Greenwood police Department. Mr. Barr also began to yell insults at myself and Lt. Powell and other officers at the scene. Mr. Barr began to distract Lt. Powell and I from conducting our official police duty. Mr. Barr was advised several times by myself and Lt. Powell to leave the scene but he refused to do so. Mr. Barr was then advised that he was under arrest he began to walk off the scene. I approached Mr. Barr and placed him in handcuffs and advised him again that he was under arrest. Mr. Barr was placed in my patrol unit and transported to the county jail for booking. While transporting Mr. Barr to the county jail he stated that he was going to continue to come on the scene of the police scenes.
