**LIMITED RESPONSE AND OBJECTION TO MOTION FOR
ORDER COMPELLING JOHN COLEMAN TO APPEAR
FOR CONTINUED § 341(a) MEETING OF CREDITORS**

COMES NOW John Coleman (the “Debtor”), and files this his Limited Response and Objection to the *Motion for Order Compelling John Coleman to Appear for Continued § 341(a) Meeting of Creditors* (the “Motion”) [DK#138], filed herein by the Office of the United States Trustee (the “UST”), and, responding to the Motion, would respectfully respond as follows, to-wit:

1. The Debtor is going to waive his discharge in either this Chapter 11 case or in the Chapter 7 case if the Court sees fit to convert the pending Chapter 11 case to a case under Chapter 7.
2. The Debtor will exercise his privilege against self-incrimination if compelled to appear and/or testify at any hearing or meeting of creditors in this case, so an order compelling the Debtor to appear will not further the interests of creditors or parties-in-interest in this case as it now exists and/or as it may be converted.
3. Other grounds to be assigned upon a hearing hereof..

WHEREFORE, PREMISES CONSIDERED, Debtor respectfully prays that, based upon the representations contained in this Limited Response, the Court will dismiss the Motion. Debtor prays for general relief.
