MOTION FOR AUTHORITY TO SELL EQUIPMENT OUTSIDE THE ORDINARY COURSE OF BUSINESS FREE AND CLEAR OF LIENS, CLAIMS AND INTERESTS

COMES NOW Express Grain Terminals, LLC (the "Debtor") and files this its *Motion for*Authority to Sell Equipment Outside the Ordinary Course of Business Free and Clear of Liens,

Claims and Interests (the "Motion"), and in support thereof, would respectfully show unto the Court

as follows, to-wit:

- 1. On September 29, 2021, the Debtor herein filed with this Court its Voluntary Petition for bankruptcy under Chapter 11 of the Bankruptcy Code (the "Petition").
- 2. This Honorable Court has jurisdiction of the subject matter herein and the parties hereto pursuant to 28 U.S.C. § 157, 1334; 11 U.S.C. § 105, 363, 541, 1107, related statutes, related rules and various orders of reference. This is a core proceeding.
- 3. In the exercise of the Debtor's best business judgment, the Debtor has made the decision to liquidate certain equipment in an effort to generate credits to pay the indebtedness of creditors.
- 4. Specifically, the equipment that forms the subject matter of this Motion are thirty-four (34) various vehicles and trailers (the "Vehicles"). It is the Vehicles the Debtor desires to sell. A copy of a list of the Vehicles is attached, incorporated by reference and marked as **Exhibit "A"**.

5. The decision to liquidate the Vehicles is in the best interest of all creditors and parties-in-interest herein. The Debtor does not yet have purchasers for the Vehicles but is seeking purchasers for the following "floor" prices:

These "floor" prices are the minimum fair market values of the Vehicles.

- 6. The purchasers of the Vehicles will be good faith purchasers and the sale transactions will be arms-length transactions.
- 7. The Debtor seeks authority of the Court to execute such bills of sale, transfers of title or other related documents which are reasonably necessary to consummate and close the sales of the Vehicles once it secures purchasers. Debtor requests that Dennis Gerrard, the duly appointed CRO of the Debtor, be authorized to execute the transfer documents.
- 8. The Vehicles are to be sold free and clear of liens, claims and interests, since there are no liens upon the vehicles.
- 9. Upon closing, the sales proceeds shall be placed in an interest bearing escrow account at an Office of the United States Trustee authorized depository by counsel for the Debtor, with the funds to be disbursed only upon further order of the Court, after notice and a hearing.

- 10. The Debtor requests that the Court approve the sales of the Vehicles for the fair, reasonable, and appropriate "floor" prices as set forth above, so that further orders are not necessary, so long as the Debtor sells the vehicles for the prices in Paragraph 5.
 - 11. Other grounds to be assigned upon a hearing hereof.

WHEREFORE, PREMISES CONSIDERED, Debtor respectfully prays that upon a hearing hereof, this Honorable Court will grant the Motion authorizing Debtor to sell the Vehicles free and clear of liens, claims and interests, and to execute such bills of sale, transfers of title or other related documents to transfer good title to the Vehicles. Debtor prays for general relief.
