GRESHAM PETROLEUM COMPANY'S MOTION FOR ALLOWANCE AND PAYMENT OF ADMINISTRATIVE EXPENSE CLAIM PURSUANT TO 11 U.S.C. § 503(b)

Comes now Gresham Petroleum Company ("Gresham"), and files this Motion for Allowance and Payment of Administrative Expense Pursuant to 11 U.S.C. § 503(b) (the "Motion"). In support of the Motion, Gresham states the following:

RELIEF REQUESTED

1. By this Motion, and pursuant to Section 503(b)(9) of title 11 of the United States Code, 11 U.S.C. §§ 101 *et seq.* (the "Bankruptcy Code") Gresham seeks entry of a final order allowing its administrative expense claim for certain outstanding prepetition purchase orders owe to Gresham and ordering immediate payment of this claim.

JURISDICTION, VENUE, AND AUTHORITY

- 2. The United States Bankruptcy Court for the Northern District of Mississippi (the "Court") has jurisdiction over this Motion pursuant to 28 U.S.C. § 1334.
 - 3. This matter is a core proceeding under 28 U.S.C. § 157(b).
- 4. Venue of the Chapter 11 Case and related proceedings is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409.

DISCUSSION

- 5. On September 29, 2021 (the "<u>Petition Date</u>"), the Debtor filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code (the "<u>Chapter 11 Case</u>").
- 6. The Debtor was an agricultural processing and marketing company with facilities located in Greenwood, Minter City, and Sidon, Mississippi. The Debtor manufactured, marketed, and distributed a variety of products including soybean oil, high protein soybean meal, soybean hulls and pellets, and biodiesel. The processes used to store grains and produce such products require large amounts of propane and diesel fuel as well as machine lubricants (collectively, "Fuel").
- 7. The Debtor purchased this Fuel from Gresham which is unaffiliated with the Debtor and had done so for a number of years leading up to the Petition Date.
- 8. Gresham and the Debtor operated on a purchase order system whereby Fuel was purchased and payment was due on the 25th day of the month following thirty days from the date of the delivery. The Debtor owes Gresham \$245,907.38 for Fuel delivered to the Debtor by Gresham before the Petition Date for which payment has not been made (the "Prepetition Claim"). Of this amount, \$83,262.95 is for Fuel delivered within the 20 days before the Petition Date. Attached hereto as **Exhibit A** is Gresham's Proof of Claim [Claim No. 26] (the "Proof of Claim") in which copies of invoices supporting the Prepetition Claim are enclosed. Both through its Proof of Claim and now through this Motion, Gresham asks the Court to grant it an administrative expense claim for the \$83,262.95 and order the claim to be immediately paid.
- 9. Section 503(b)(9) of the Bankruptcy Code allows an administrative expense for "the value of any goods received by the debtor within 20 days before the commencement of a case

under this title in which the goods have been sold to the debtor in the ordinary course of such debtor's business." 11 U.S.C. § 503(b)(9).

- 10. Gresham sold the Fuel to the Debtor during the ordinary course of the Debtor's business and the Debtor received the Fuel within twenty (20) days of the Petition Date. This Fuel allowed the Debtor to continue to operate its business resulting in Gresham providing a benefit to the Debtor's bankruptcy estate.
 - 11. Gresham filed its Notice of Reclamation Demand [Doc. 206] on October 19, 2021.

NOTICE

12. Notice of the Motion has been provided by telecopy, email, overnight courier, and/or hand delivery to the following parties, or, in lieu thereof, their counsel: (i) the U.S. Trustee for the Northern District of Mississippi; (ii) Counsel for UMB Bank, N.A. including: Andrea M. Chase, E. Franklin Childress, Jr., R. Spencer Clift, III, Eric Johnson, and Peter L. Riggs (the "Notice Parties"). Gresham avers such notice is sufficient and complies with section 102(1) of the Bankruptcy Code, Bankruptcy Rules 2002, 4001(b) and (c) and 9014 and the Local Rules.

NO PRIOR REQUEST

13. Gresham has not previously sought the relief requested herein from the Court or any other court.

CONCLUSION

14. WHEREFORE, for the reasons set forth herein, Gresham respectfully request that the Court enter the Proposed Order, attached herein, granting the relief requested and, such other and further relief as is just and proper.
