RE: Request for you to Cease and Desist Dissemination of Slanderous, False and Defamatory Statements Against Me and Request For Retraction of Slanderous, False and Defamatory Statements dissemination on September 2, 2022, and September 6, 2022.


Dear Mr. Adams:

It has been brought to my attention that you and your campaign workers have disseminated campaign literature which is slanderous, false and defamatory. The statements and headings on the literature that you and your campaign workers disseminated is slanderous, false, defamatory and has caused irreparable harm to my reputation. Your actions have and continue to have the ability to cause me significant and irreparable financial harm. Specifically, several Leflore County voters have shared a copy of the literature you disseminated and videos from Ring doorbells where you and your campaign workers delivered this false information to their homes in Schlater on September 2, 2022, and to Greenwood residents on September 6, 2022.

I am requesting that you cease dissemination of the slanderous, false and defamatory flyers immediately and that you disseminate within forty-eight (48) hours literature which correctly states that the allegations of forgery made by my family were false in as much as you are aware that the litigation has ended. Specifically, you are aware based upon the court orders filed in the Estate of James Littleton in the Bolivar County Chancery Clerk's Office, as well as the court order filed in the Leflore County Chancery Clerk's Office that I did not forge the name of my sister and mother on deeds in my late father's estate. Prior to handing your campaign literature out, you had a duty to determine the outcome of that litigation so that you could report the truth if you decided that you wanted to embark upon this subject. You failed to report the truth even though you know that litigation has concluded. As such, within forty-eight (48) hours, please print and disseminate a retraction to all of the households in Schlater and Greenwood, MS

where you have delivered this slanderous literature. Your failure to print a retraction and to provide me with a copy of the retraction will result in a lawsuit being filed against you for monetary damages sufficient to compensate me from the harm to my reputation. Additionally, I intend to seek punitive damages against you in an amount sufficient to deter your slanderous and *defamatory conduct in the future*. I am enclosing a copy of the literature which is *defamatory* and I am also enclosing a copy of the court order which clearly shows that I did not forge any deeds as family members and you have falsely alleged.
