

**PETITION FOR ORDER REQUIRING  
NIGHT OWL SECURITY PRODUCTS TO PRODUCE VIDEO FROM USERNAME  
"APRIL7783" AND/OR UID 24P2 9PYW 36L2 8P9C 111A  
FOR THE TIMES OF 12:00 P.M. CENTRAL STANDARD TIME ON JULY 09, 2022  
THROUGH 1:00 A.M. CENTRAL STANDARD TIME ON JULY 10, 2022**

COMES NOW, THE STATE OF MISSISSIPPI, by and through the Office of the District Attorney for the Fifth Circuit District and respectfully petitions this Honorable Court for an Order requiring Night Owl Security Products to provide and reveal all videos within their possession for Username "April7783" and/or UID 24P2 9PYW 36L2 8P9C 111A, for 12:00p.m. Central Standard Time on July 09, 2022 through 1:00a.m. Central Standard Time on July 10, 2022, and in support thereof would show unto the Court that there is probable cause, to wit:

1. On July 09, 2022, the Carroll County Sheriff's Department received a call regarding a house fire at Vaiden Rental Apartments, Apartment #14..
2. It was reported that two (2) individuals were believed to be inside the apartment.
3. Following a search of the apartment, the body of Orlando King Pittmon was found inside of a utility room, located off of the main living room. This body was inside of a duffle bag, with bedding materials packed on top and around him.
4. In the same room, a deceased K9 was found with a knife blade protruding from his body.
5. Because of how the body of Orlando Pittmon was situated, it is believed that he was deceased before the fire occurred.

6. In the main living room, deputies located a camera system box. This box was connected to cameras in the living room that deputies believe captured the events that led to Orlando Pittmon's death.
7. When deputies attempted to playback the video from the camera box, it shut down repeatedly, potentially due to damage suffered during the fire.
8. These cameras are connected via wifi to cloud storage controlled by Night Owl Security Products.

There is an ongoing criminal investigation into the above-mentioned matters and an Order for Night Owl Security Products to produce and provide to the State all videos within their possessions for Username "April7783" and/or UID 24P2 9PYW 36L2 8P9C 111A, for 12:00p.m. Central Standard Time on July 09, 2022 through 1:00a.m. Central Standard Time on July 10, 2022 will provide the State with relevant and material information concerning said investigation.
